River City Bass Club (RCBC) 36th Annual Open Bass Tournament Sunday, October 14, 2012

OFFICIAL RULES

- All entry fees must be paid before 6:30AM October 14th, 2012 1.
- 2. A team will consist of two fisherpersons fishing from the same boat. One person may fish alone if they pay a full \$100 entry fee.
- Contestants cannot fish Lake Belton during the hours between 6:00PM Saturday, October 13th and 3. 6:30AM, Sunday, October 14th 2012.
- 4. Fishing hours are from 6:30AM to 3:30PM on October 14th, 2012. (NO EXCEPTIONS - SEE RULE 15)
- 5. Official time will be by KVET Radio 1300 KC AM.
- All fish must be caught on artificial lures by casting, using one rod and reel at a time. NO TROLLING. 6.
- 7. Only Largemouth, Smallmouth and Spotted Bass may be weighed. (MINIMUM LENGTH OF 14 INCHES)
- Any team attempting to weigh-in a fish less than 14 inches will be disqualified. 8.
- 9. Fish will be measured with mouth closed and tail compressed.
- 10. There will be a 5 fish limit per team – any team attempting to weigh-in more than 5 fish will be disqualified.
- Each boat must have a properly aerated livewell able to maintain alive a limit catch of bass. No iced, 11. frozen, or pale gilled fish will be weighed. The decision of the Tournament Director will be final.
- 12. All fish weighed-in become the property of the River City Bass Club with the exception of trophy bass. A live release program will be in effect.
- 13. The River City Bass Club will take every precaution to assure a live release. Tournament contestants must go through a separate line to obtain a weigh-in bag provided by the River City Bass Club. No other bags will be accepted in the weigh-in line. Contestants who have not been through or are not in line to pick up a weigh-in bag by the 3:30PM deadline will be considered late and will be disqualified.
- Contestants that violate Federal or Texas State Game Laws will be disqualified.
- 15. Any contestant or team that violates any tournament rule will be disqualified.
- 16. River City Bass Club reserves the right to reject any application.
- 17. Any protest must be in writing to the judges within 30 minutes after weigh-in.
- 18. All winners may be subject to a polygraph test.
- 19. River City Bass Club is not responsible or liable for injury or loss of property.
- 20. Ties will be decided by a toss of a coin.
- 21. All monies awarded will be by check.
- 22. Trailering is allowed.
- 23. There will be a ¼ pound deduction for each dead fish. The ruling will be made by the Tournament Director and all decisions are final.
- 24. U.S. Coast Guard approved life jackets must be worn and fastened and a kill switch used while the big engine is running.
